#### **REMINDERS RE: TAX DEADLINES**

For Texas, Oklahoma, and Louisiana ONLY: For all tax returns (business and personal), as well as 2020 tax liability payments and 2021 estimated payments, the IRS has automatically extended the deadline to JUNE 15, 2021, due to the severe winter storms.

For all other states: The IRS has automatically extended the deadline to FILE the tax return to May 17, 2021. Any tax liability or quarterly estimated payments are STILL DUE April 15, 2021.

Please bring or send your data for your 2020 income tax return as soon as you are ready! We look forward to assisting you again this year.

#### **IRS NOTICE 1444**

If you received a stimulus payment, you should have received a letter - IRS Notice 1444 - which is simply a confirmation of your relief payment. Please save this notice and include it with your supporting documents. If you do not have the notice, please include information on what payments you received so the Tax Preparers can include the info on your return. If you did receive

the full amount, you won't need to claim the recovery rebate credit.

The Biden Administration announced changes to the **Paycheck Protection Program (PPP)** to increase lending to smaller businesses and help ensure equitable distribution of loans to them. But qualified

#### **EMPLOYEE RETENTION CREDIT**

As part of the Covid 19 relief legislation, Congress established the **Employee Retention Credit.** If you are a small business owner with employees this could be very beneficial for you.
