UPCOMING DEADLINES

September 15 - deadline for **S-Corporation Returns (Form 1120S)**
and **Partnership Returns (Form 1065)**

September 30 - deadline for **Estate/Trust Returns (Form 1041)**

October 15 - deadline for **Individual Returns (Form 1040)**

HOW TO GET YOUR SUPPORTING DOCS TO US

- **Drop them off** at our office (if you are local)
- **Mail them** to our office (we highly recommend sending Certified Mail or getting a tracking number)
