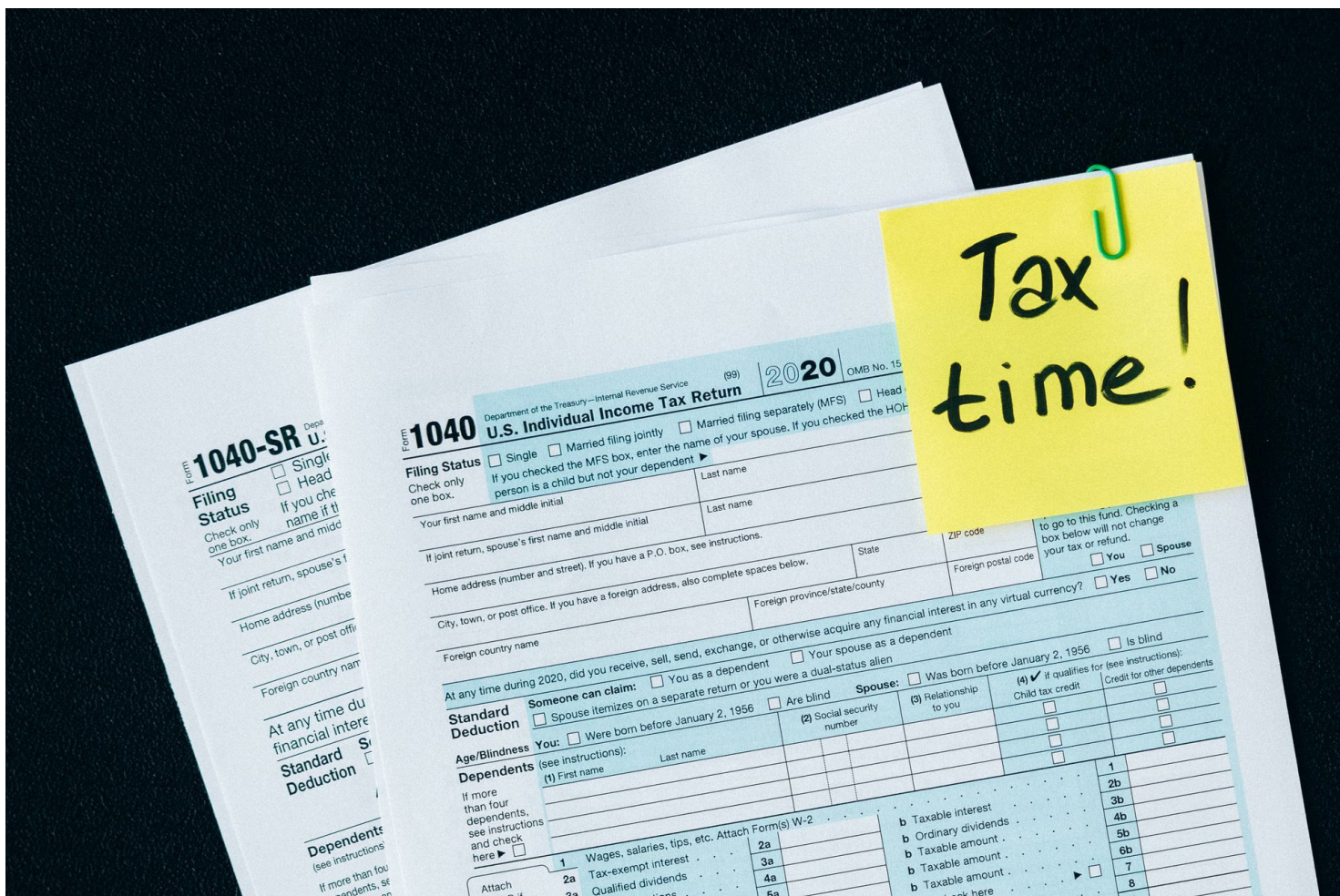

October 15 - Extension deadline for **Individual Returns (Form 1040)**
and **Corporate Tax Returns (Form 1120)**
