### IT'S TAX DEADLINE TIME!

- The deadline is fast-approaching on **April 18** and we are doing our best to get returns completed.
- For those who are still waiting on some of their supporting docs to arrive and for those who brought in their documents just recently, **we will very likely have to file an extension for you.**
- **AN EXTENSION IS AN EXTENSION OF TIME TO FILE, NOT TIME TO PAY.**
- **If you think you may owe with the extension,** please send any income documents to us so that we can estimate what you need to pay with the extension. **You will receive an estimated payment voucher via email that you will need to send in via Certified Mail** along with the estimated payment by April 18, 2023, and we will e-file the extension.
- **Still need to ACTIVATE your portal?** Contact [jennifer@falgoutcpa.com](mailto:jennifer@falgoutcpa.com) if you did not receive a link.
- If you call our office, **PLEASE listen to the prompts** to reach a specific staff member, as we do not have a receptionist. We have changed the phone system to an auto-attendant (voicemail) because we were receiving too many robo-calls and sales calls, and because we are short on staff.
